A Corporate Member is entitled to <b>one voting representative at the General Assembly</b>, and has the right to <b>ten attendants</b>, with spouse, at any event organized by the Nordic Chamber of Commerce at no cost or at a reduced price.</p> <p><b>The annual fee is 10.000 Kuna.</b></p>

(The annual worldwide turnover of a legal entity considered as a Business Member should be HRK 16 million or less). A Business Member is entitled to <b>one voting representative</b>, and has the right to <b>3 attendants</b>, with spouse, at any event organized by the Nordic Chamber of Commerce at no cost or at a reduced price.</p> <p><b>The annual fee is 5.000 Kuna.</b></p>

<input type="checkbox"/> <b>PHYSICAL PERSON – INDIVIDUAL MEMBER</b>	<p><b>A physical person (a citizen of a Nordic country or a Croatian citizen employed in a Nordic company/institution)</b> can become an individual member of the Nordic Chamber of Commerce in Croatia, if the Board of Governors on the proposal of Executive director decide so. Individual member is entitled to one vote at the General Assembly and has the right to <b>attend</b>, with spouse, any event organized by the Nordic Chamber of Commerce at no cost or at a reduced price. Individual member does not belong to any of the membership categories mentioned above.</p> <p><b>The annual fee is 1.000 Kuna.</b></p>
